## VENDOR CRITERIA:

We are seeking vendors desiring to share their company products, services, and information with Route 66 Steps For Success race participants and guests. Vendor space will be located in front of the Creek County Courthouse. The race registration, race starting point, and the event stage will also be located in this area.

In an effort to maintain race quality, the following criteria has been established for all vendors. Vendors adhering to this criteria will be given first priority of table location. The race Steering Committee reserves the right to decline any vendor not meeting the criteria.

- Vendors must secure their space by September 1, 2009 to ensure a space.
- Vendors must supply their own table (booth), chairs, and needed equipment.
- Allotted table (booth) space is approximately 10' x 10'.
- Each vendor assumes all liability for all action and activities occurring in the vendor's area and holds Route 66 Steps For Success harmless of all accidents, thefts, fires, damages, and any other non-designated liabilities.
- Each vendor must have liability insurance or agree to be responsible for liability within their booth, serving area, or immediate area around their booth.
- Each vendor will be assigned a space which will be identified via markings on the parking lot pavement in front of the Courthouse.
- Vendor set up time is Saturday, November 7, 2009 after 11:00 A.M. All vendors must be set up by 1:00 P.M. (race time).
- Vendors cannot park vehicles on the grass or in the Vendor parking lot where booths are located. All vehicles should park outside the Courthouse parking lot.
- Vendors are responsible for their own electricity.
- Vendors are responsible for cleaning their own table area and dispensing of trash at conclusion of event.
